# Hearing Screening Course - Level 1

## Initial Training & Renewal - Lawrence, Kan.

### October 18-19, 2021

#### **PROGRAM DESCRIPTION:**

This program is designed to certify people for Hearing Screening Level 1. Day one includes an overview of the Hearing Screening Law and pertinent information in order to allow the participant with the skills to complete hearing screenings and visual inspections and will be able to explain the results. Day two includes a clinical practicum. Participants completing the program will be able to perform Otoscopic inspection, pure tone air conduction sweep screening and threshold screening. Those who complete this program will meet the requirements of Level 1 Certification of the KSA 72-1204 through 1207.

#### **OBJECTIVES:**

At the conclusion of the course, participants should be able to:

1. Describe the basic anatomy and physiology of the ear, and common hearing disorders.
2. Describe signs/symptoms of hearing loss.
3. Explain the hearing screening law, the rationale for mandatory hearing screening, and the need for early identification.
4. Demonstrate how to explain the hearing screening process to the pediatric population.
5. Demonstrate a visual inspection.
6. Demonstrate how to complete a listening check to ensure audiometer is working accurately.
7. Determine if an environment is conducive to performing hearing screenings.
8. Demonstrate air conduction sweep frequency screening, threshold screening, play audiometry procedures, and otoacoustic emission screening.
9. Analyze audiograms to determine if there is need for a referral.
10. Demonstrate interpretation of hearing screening results and need for appropriate follow-up.
11. Record and maintain hearing screening results and reports accurately.
12. Identify complex screening situations to report to audiologist or supervisor/coordinator of the hearing screening program.
13. Recognize current issues in hearing screening.
